#### **ACCOUNTANT'S REPORT:**

The Accountant's Report – The Board reviewed the 9-month Financial Report as submitted by the Accountant. The bottom line for the nine months ending June 30, 2016 showed a loss of \$24,082.

Ms. Avena presented the revised 2016-2017 budget including changes from the budget presented at the June 2016 meeting. These changes include calculation of subsidy at 86%; additional funding allocated for administrative salaries; overtime and contract costs.

### **BROAD STREET CONCRETE WALL:**

The E.D. and the Site Manager are gathering quotes to repair the damaged wall on Broad Street Court and some uprooted sidewalks. The Authority received one quote from Ocean Construction. The Authority has submitted a claim to the Insurance Company who will be issuing a check for these repairs, minus the deductible.

The Authority is in the process of advertising for quotes for the following providers: Legal Services, Accounting Services and Auditor.
